(1) Attention is invited to the Notification No.01/2017-Central Tax Date 19.06.2017 of the Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise & Customs, whereby the Central Government has appointed the **22nd day of June, 2017**, as the date on which the provisions of sections 1, 2, 3, 4, 5, 10, 22, 23, 24, 25, 26, 27, 28, 29, 30, 139, 146 and 164 of the said Act shall come into force.


(2) Attention is also invited to the Notification No.02/2017-Central Tax Date 19.06.2017 of the Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise & Customs, whereby Government of India has appointed the Chief Commissioner, Central Tax, Vadodara Zone and other subordinate officers in Vadodara Zone as reproduced in **Annexure-A** to this Trade Notice.

2. Consequent upon implementation of Central Goods and Services Tax Act, 2017, w.e.f. 22.06.2017, in exercise of powers conferred upon me under Sub-section (2) of Section 5 of Central Goods and Services Tax Act, 2017, the Jurisdiction of Various field formations of Central Tax Commissionerates viz. Commissionerate, Divisions/Circles, Ranges, including that of Commissioner (Appeals) and Additional Commissioner (Appeals) in Vadodara Zone are defined and notified as detailed in **Annexure-B & B1** to this Trade Notice. Further, the jurisdiction of the Ranges of each of the Divisions of the Central Tax Commissionerates, Vadodara Zone are redefined and notified as per details in **Annexure-C** to this Trade Notice.

3. This Trade Notice supersedes all trade notices issued earlier in this regard.
