Subject: - Setting up of an IT Grievance Redressal Mechanism to address the grievances of taxpayers due to technical glitches on GST Portal - Reg

Attention of the trade is invited to the Circular No. 39/13/2018-GST dated 03rd April 2018 issued by Central Board of Indirect Taxes and Customs (CBIC) on subject of an IT Grievance Redressal Mechanism to address the grievances of taxpayers due to technical glitches on GST Portal (copy of the said circular is enclosed).

The taxpayers shall make an application to the field officers or the nodal officers where there is demonstrable glitch on common portal in relation to an identifiable issue, due to which the due process as envisaged in law could not be completed on Common Portal. The applicants shall enclose the evidences for an identified issue to establish the bonafide attempt on the part of taxpayers to comply with the due process of law. The nodal officer will collate all the applications and forward it to GSTN for further examination. The GSTN after verifying electronic records will forward it to IT Grievance Redressal Committee with suggested solution.
